



## STALLION SERVICE AGREEMENT

**I agree to the following Terms & Conditions:**

1. Live Foal Guarantee; Live Foal means the foal shall stand & nurse. Mare owner agrees that Stallion owner and/or attending veterinarian does not make any guarantees as to the quality or confirmation of the foal nor that the foal will be free of any infirmity, conformation defect, disease or inherited trait. It is understood that if the mare proves barren, aborts her foal or if the foal is stillborn, a return season will be guaranteed the following year only, provided proper notification is given. Proper notification is a veterinarian certificate.
2. This agreement shall not be assigned or transferred by the Mare Owner without the written consent of McCormick Equine Performance.
3. If the above mare dies or becomes unfit to breed, the Mare Owner may substitute another mare for the following breeding season only. No money will be refunded.
4. If the above named Stallion should die or become unfit for service, the Mare Owner may have their booking fee \$700 refunded.
5. McCormick Equine Performance is not responsible for lost, delayed or damaged semen and makes no representations or warranties of any kind.
6. McCormick Equine Performance shall issue a Breeders Certificate per appropriate association rules.
7. It is the responsibility of the mare owner to register the foal and insure that the procedure is in accordance as prescribed by the appropriate association. McCormick Equine Performance agrees to provide necessary documentation to the mare owner.
8. All veterinary costs are the Mare Owners responsibility.
9. Service Fees must be paid in full and payment cleared before semen will be dispatched.

## **BREEDING AGREEMENT – ON FARM**

1. For Mares bred on farm the breeding service fee with all other fees, including agistment, vet & farrier expenses will be paid in full prior to the departure of the mare from the stud, but no later than at PTIF 42 days.
2. Agistment will be charged from the date of the mare/s arrival at the stud until the date of departure @ \$10 daily.
3. All veterinary expenses incurred for the mare, including pregnancy tests, will be paid by the mare owner. The mare owner warrants that to their knowledge the mare is in good health and has not been in contact with contagious Equine Metritis, Equine Influenza, Strangles or any other infectious disease. McCormick Equine Performance may at any time and at the expense of the mare owner have the mare examined for any such infectious disease or for any purpose whatsoever by a veterinarian nominated by McCormick Equine Performance. McCormick Equine Performance may treat the mare as deemed necessary by the veterinarian or reject the mare where upon the mare owner will immediately remove the mare and pay all costs, fees & expenses outstanding.
4. All transport arrangements and costs shall be the responsibility of the mare owner. The mare owner must give at least 24hrs notice to McCormick Equine Performance of its intention to deliver or collect the mare. If the mare owner is notified by McCormick Equine Performance to collect the mare and fails to do so within 14days, then McCormick Equine Performance may move the mare to such property of its choosing and all expenses associated will be the responsibility of the mare owner.
5. Whilst the mare is in the custody of McCormick Equine Performance, McCormick Equine Performance shall not be liable for any sickness, disease, injury or death which may be suffered by the mare or its progeny. McCormick Equine Performance warrants all necessary precautions will be taken to ensure the well being of the mare and its progeny. Should McCormick Equine Performance be unable to or fail to perform this contract by reason of death or injury or sale of the stallion, all fees paid by the mare owner will be refunded and neither party shall have any rights against the other.
6. Pregnancy tests will be carried out by a veterinarian nominated by McCormick Equine Performance 42days after service. If the mare shall be found to be not pregnant then no service fee shall be payable but all other monies herein mentioned shall be paid and this agreement shall in all other respects be performed and observed. The veterinarians certificates of pregnancy examination shall be the property of the mare owner.
